projects and once again prove our competency and efficiency in these markets.

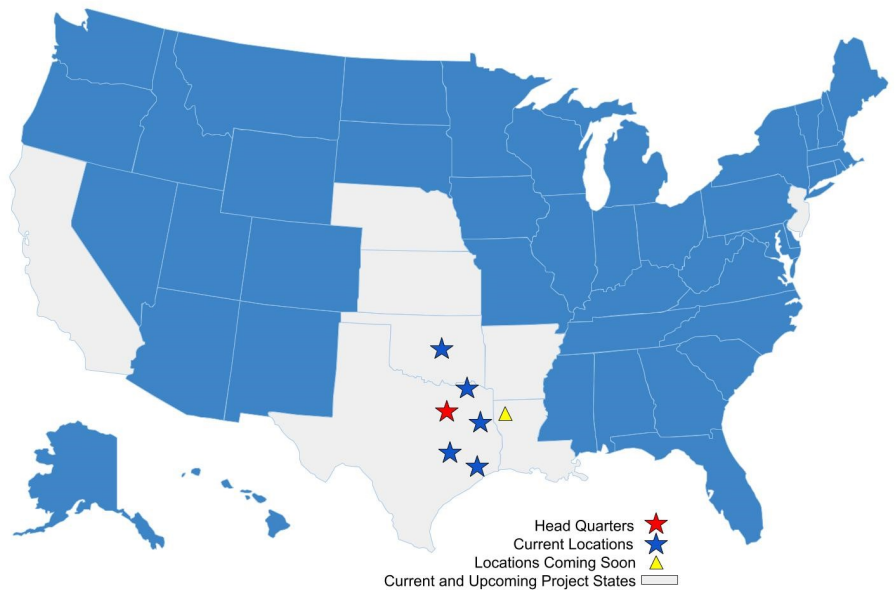
